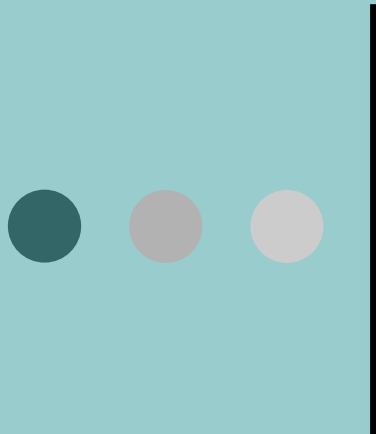

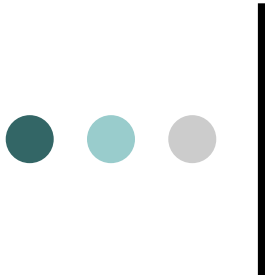

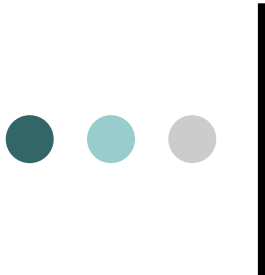
Background

- BES took over the contract from Bureau Veritas in August 2022
- Pressure System Safety Regs.
- Lifting Operations and Lifting Equipment Regs.
- BES are our 'competent person' to undertake inspections in line with these regulations

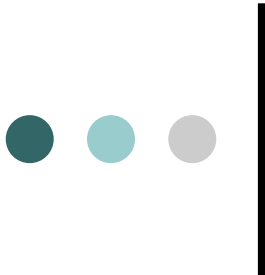

Initial Issues

- BV left the Contract in a poor state
 - 100's items left not inspected
 - Many Plant Not Available (PNA's) issued
- BES were not expecting this
 - Playing catch up from the word go
 - Trying to keep on top of scheduled assets inspection dates

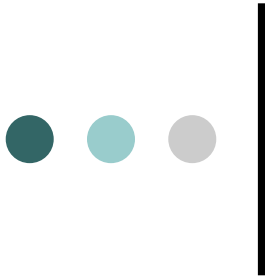




Initial Issues

- Working on Data from BV
 - Duplicate entries
 - Things on the list that had been scraped
 - Items missing in the transfer of data
 - Items listed in wrong location so unable to find





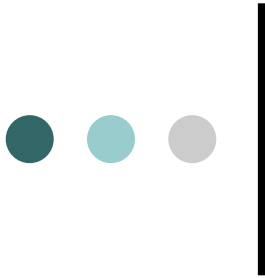
Initial Issues

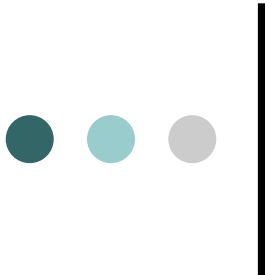
Improvements

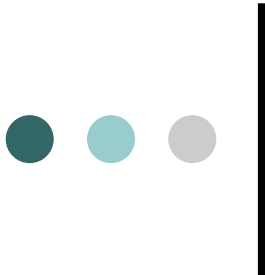
Departmental Responsibilities

- Name a responsible person
 - Keep the Safety office informed of changes
- Keep your asset register up to date
 - Remove items not in use
 - Add new assets to the register and inspect before use

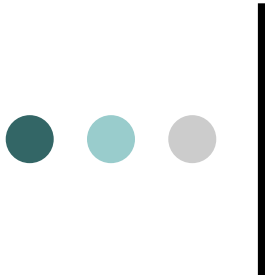
Departmental Responsibilities

- Arrange for inspections to be completed before the current certificate expires
- Arrange for 3rd party engineer to be present on the day if required.

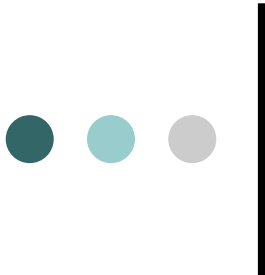
PNA's

- Issued when inspection cannot go ahead:
 - Contact could not be made with dept.
 - Asset could not be found
 - Asset was in use on the day
 - Asset was not prepared

PNA's

- BES have fulfilled the contract
- BES will not chase to inspection
- It is YOUR RESPONSIBILITY to contact them to rearrange
 - DO NOT use the equipment until inspected
 - Switch off / isolate / sign DO NOT USE
 - It is NOT insured out of inspection date
