1. University Register of Safety Legal Responsibilities and Obligations

1.1. Introduction

This register provides a detailed list of all relevant health and safety legal responsibilities and obligations applicable to the University's undertakings and health and safety management system.

The register has been compiled into four tables which detail:

- 1. core legislation which applies to all health and safety risks in all relevant situations
- 2. legislation which applies to specific health and safety risks
- 3. approved codes of practice having legal status with relevance for health and safety risks
- 4. legislation with indirect relevance for health and safety risks.

It should be noted that following the United Kingdom's exit from the European Union (Brexit), the implementation of the Health and Safety (Amendment) (EU Exit) Regulations 2018 ensure that European Union ('EU') derived health and safety protections continue to be available in domestic law. However, amendments published by the EU after 11pm on 31 December 2020 do not apply to retained law. From a health and safety perspective, most of the retained legislation is around chemicals regulation.

This register will be reviewed and updated annually ready for presentation to the Lent Term Health and Safety Executive Committee (HSEC) by the Safety Office.

Approved codes of practice (ACOPs) have special legal status. This is shown by the annotation [LXX], where [LXX] is the Health and Safety Executive (HSE) 'Legal Series' publication number [XX]. They are detailed guidance documents approved by the HSE and published to accompany a set of health and safety regulations. They help you to comply with your legal requirements. If you are prosecuted for breach of health and safety law, and it is shown that you did not follow the advice given in the ACOP, you will need to show that you have complied with the law in some other way or a Court will find you at fault.
